- 2) Review Previous Minutes and Action Items Wilma moved to approve minutes, seconded by Gordon, passed.
- 3) Fahe Membership Business
  - a. Caucus to review recommendation for a new Nominating Cmte representative as Dave Kreher is retiring.
  - b. Dave nominated Wilma Kelley. Tom made motion, Scott seconded, motion passed. Wilma new committee representative. Slideshow about Dave's impact.

  - d. President's Report Jim King Working on strategic plan draft at the spring retreat and caucus meeting, will have more of an update. Hope to have that set to guide collective work over the next 5 years. Annual meeting the last session, Justin Maxson and Dana from Heron Foundation no clear Theory of Change, working on that now. Heron Foundation and USDA agreed to sit downs to codify the theory of change. Spring retreat the two days in DC as a group are

important and an investment, April 25 and 26, inviting Marion McFadden who is HUD Deputy Secretary to come and speak to the group. Inviting Will McIntee from the White House as well. Have done one Advocacy training, have two more upcoming trainings and also Fahe employees can go to the congressional meetings with members if desired.

#### **4) USDA Updates** - Blaine Barnes

- a. 504 Exceptions and Waivers Presidentially Declared Disaster Areas
- b. A number of exceptions have been approved, more coming. Language was not clear, getting clarification from national office. Think further exceptions will include 504 grant, age-limit waived, raise the income to the low-income limit 80% instead of 50%. Raise grant to around 40,000 for counties officially declared disaster counties. Would also include more counties as well. New 504 worksheet coming, get process quickly. Changed infrastructure. Should have final clarification by end of this month or first part of March. If you have an applicant right now, will try to get those approved if qualify. 50M set aside for this (exceptions). 4% percent, in April may go up to 4.125%. Statute do we need to reach out to Congress, will let them know timeline.
- c. 502 Direct Loan Interest Rate going up.
- d. Three vacancies across the state at the moment as well. If you know anyone would recommend, let them know.
- e. Good Response to 3D building presentation

## **5) KHC Updates** - Curtis Stauffer, Keli Reynolds

- a. ARPA program(s) status, HOME-ARP with Supportive Housing
- b. 2M is being reallocated to housing development. The first round of funding was awarded in early February, the second Kentucky Housing has 4 teams including Lexington. KHC Multi-family, timeline is fuzzy on that. Direct any questions on that to Anthony Wright. Applications have stopped being taken on January 20th but funding is still available with Home Assistance fund.
- c. Tentative timeline for application for HP/HR funding, in the process of reviewing applications, hope to meet beginning of March to decide funding, end of March will be announcement and award emails.
- d. Staff update if have HR questions in the next month, make sure it is sent to the HR inbox, not someone directly.
- e. KHC 2023 Conference is August 23-25 in Lexington this year.
- f. Taking 8-10 weeks to get money back and get things processed for HR draws. If anything missing, would be easier to email instead of having to resubmit everything.

#### 6) Federal Home Loan Bank Update - Cassandra Larcarte

Congratulations to AHP Award winners: Beattyville Housing, Frontier Housing, HDA, KCEOC, & Partnership Housing!

- Changes on website helping those who are buying a home, not necessarily first-time home buyer. Went from 5000-7500 and from 10000 to 15000 for veterans. First round opened February 6, second round July 6. Money can be used all in the first round or split it depending on how want to split it. New this year, seeing how it goes.
- Carol M. Peterson Housing Fund Several people advocated for program. This year, funding will increase, don't know the exact amount yet. See Information in packet.
- AHP Hoping to go back to workshops, April 28<sup>th</sup> in Franklin TN, May 11<sup>th</sup> in Lexington. More information will be sent out in April.

For those who have not received final funding, having some issues with the system, trying to do everything digitally, hoping by end of the year to have all progress reports ready. Zero interest fund – availability is 100k in early costs like acquisition – can use with AHP. Is a Zero interest loan, not a grant.

- DRP Funds are out there and available, rebuilds or renting. May raise rental amount.
   Federal Housing finance Agency roundtable to identify ways to reshape federal rates/programs to make it more user friendly, meeting on February 27<sup>th</sup> focusing on affordable housing.
   Recommended Sara Morgan but everyone is welcome to watch, just have to register.
- 2023 Community Support statements are due submit a comment about federal home bank. Potential program targeted fund but thinking of potential needs. Centered around mobile homes how are people currently working, is there anything for mobile homes? Thought would be mobile home replacement, recycle mobile homes. Is this a true need in the area? Concerns about owning the mobile home but not the land underneath, what the financing would look like. Targeted funds? Less regulations than their general funds, more flexibility, more voluntary programs, more user-friendly. Needs to be a substantial amount, not 5-10k.

KY is able to get a substantial amount of funding in the next 5-10 years, 7.7M for KY, not sure exactly how that is going to roll out yet, exploring options. 25% can be used for direct grants for customers. Maintenance, looking at working with KHC. 10% for charges. Another round of stakeholders, meeting with speakers, encourage people to sign up, contact Carol Stringer carolstringer@ky.gov

**Home Energy Rebate Program** – waiting for verification on how it can be structured for home rebates, energy upgrades like solar. Energy efficient appliances.

Contractor training money.

**Greenhouse gas reduction fund** – 27M, funding announcement will be sometime this year, two parcels of money, 20M, some ability to go to nonprofits, then 7M in research, both will be very competitive. Encourage looking at their website.

Rooftop solar – would that include new construction – should include any rooftop solar. Solar panels just for single family? Not sure.

Will get questions together for the Spring retreat to be able to ask so as they are in Washington, can get a feel for that office as well and introduce ourselves. Want to make sure to be engaged and be able to use the money.

Families moving into homes, anticipating 2021 funds, HUD has approved action plans, 2022 action plan not put out yet. Pre-planning meeting with disaster recovery people, continued relationship. Updated numbers: in the packet. 123 rehabs, 6 new homes, 22 under construction, etc. Partners should be getting information about event at 1:30 pm.

Bill filling deadline is the 21st. Delayed timeline but the strategy is not changing. Need further engagement. Not going to get fully funded on Tuesday, what Andrew needs from members, identify members of your community who were impacted to join Tuesday to speak at press conference at 11:00 am. HHCK Session, then press conference. Asking members to do the introduction and conclusion of press conference, look in packet. Scott wrap it up, Cassie intro? Tell their story, explain what happened, why the funding is badly needed in their communities, give call to action to legislators, then further meetings with legislators. Find members of the public to speak. If need any transportation, may be able to make arrangements to Frankfurt. Would like to confirm several members to speak. Press release talking points and agenda in email as well. Happy to do any prep with people as well.

<u>YouthBuild</u> being used for training adults in construction trades, may be valuable if anyone is part of the YouthBuild program, trying to gather resources from the membership to cross pollinate some programs that are becoming successful and able to start their own.

    - If participated in VTI from NeighborWorks from last week, Jackie needs receipts and certificates of completion to process the reimbursements. NeighborWorks has two in person NTIs in May and in August. Training grant from NeighborWorks this time last year and purchased the self-paced classes online and been reimbursing that way, money is getting thinner and thinner. Hoping to get additional money from NeighborWorks.
    - Looking to spotlight a member in the newsletter every month, good for job openings as well. Same with the Monday email, if there is anything that is going on, let Jackie know.
  - Health & Housing Nicholaus Bormes (Trauma Informed Care (TIC) Training, Unite Us in KY) -
  - Health networking referral system focusing on specific issues. Platform works almost like social media program for referrals for individuals for organizations. Take that information to a organization that they are partnered with so prevent having to turn people away. Worked really well in VA and TN so far. Reaching out about meetings coming up, keep an eye out, member of staff can come. Working with Substance Abuse Mental Health to help create trauma-informed care training program. Increase understanding of those who have/had gone through trauma and communicate with them. Have a training program end of February, Tuesday February 21st 1-3:00 pm, training is free, not available just to members, open to anyone. Dates are in the memo in the packet. All dates are the same training, only have to attend one of them.
  - <u>Spring Retreat</u> Make the Investment! Still looking at hotel information for spring retreat, Fahe will pick up bill then bill members for whatever is used so that there is a discount from the hotel. April 25 and 26<sup>th</sup>, Tuesday and Wednesday.
  - Will have a reception/download the evening of the 26th to see how everyone feels about the day's events/meetings. If want to stay an extra day, that is on your own bill. This will be an investment that really pays off – Scott.

- d. Lending Community Lending and Just Choice Lending
  - Home dollars coming out two times this year, February/March that meet those criteria, government assistance you don't have to pay back for 5 years.
  - Created a blended rate to combat current rates, around 5%, open some doors for those who have projects ready to go. Construction/rehab is ideal for this money, not long-term financing. Bond guarantee money attached to treasury so rates fluctuate, working on recent projects creating mini-terms, i.e., 5-year term, put it on 25 PAM so rate might be 6.75% but on a 5 year term, gives a lower monthly payment. At the end of 5-year period, if rate is lower, can refinance with us or someone else but if rates are worse, would give the option to refinance at original rate for another mini-term. CF Money in 4% range, really good money but you do have to check those boxes. If you have something healthcare related or childcare related, senior facilities, those fit really well into that money. Let Drew know if you have any projects and will see what we can do.
- e. Partners for Rural Transformation Jose Quinonez, Essence Smith Signed a PRT/USDA agreement, look forward to the future, happy to give more reports on it

soon. Did a 12 series articles with Forbes, invited to do something similar with Nonprofit Quarterly, 6 articles in the future. In the process of developing PRT Rural Development training, set of talking points for CEOs when working with decision makers at the national level focusing on philanthropy. Three-legged approach, engage with federal agencies and philanthropic private ventures as well. Working hard on making persistent poverty a better place. Nonprofit Quarterly are more focused articles, PRT CEOs are working on some of those. Planning an event for October 24-27

RE: Update on Strategic plan, Theory of Change

Greetings friends, I wanted to offer an update on the purpose and then the status of our Theory Of Change (TOC), 5 year Strategic Plan, and FY 24 Goals for Fahe. My hope is that everyone would have a common understanding of our vision together and be able articulate why we do things the way we do and what we're committed to in Appalachia.

The Theory Of Change is meant to express why we do certain work, how we work together so that we address the long term and chronic disinvestment in our region. We have as a vision of our success that we are building Appalachia to be communities that people want to live in, and that they have the kind of opportunities that are similar with the rest of the country. When we work together across Fahe, we create regional level investment that leads to increased capacity, and that helps us all work together to change the narratives in our communities, and create a virtuous cycle of progress.

Regarding the strategic plan, most of you will be familiar with the basic message. We think about the next several years as building the foundation that it takes for that long-term success or that vision I spoke of earlier. The four corners of our foundation are focused on money, capacity, narrative, and people. These provide the direction for our work. It should inform what opportunities we will pursue and which ones we will not.

The goals for fiscal year 2024 fall in line with the strategy and Theory Of Change, we build the goals around the four corners in terms of status and progress. The Theory Of Change, Strategic Plan, FY 2024 goals and budget will be presented at the June 21-22nd board meeting for approval. Once approved, we will have a communication plan so that we all have key messages we can utilize. This will help us be consistent in how we speak about our work together, and when we speak with one voice, we are heard.

I'm inspired with the progress we are making in Appalachia which has faced long disinvestment and our success in this region serves as a source of hope for me when our country is struggling with a growing divide of wealth and quality of life. If we can do it here that makes me belief we can do it everywhere.

We do this with the knowledge that it's our Strength in Numbers that gives us the power to leverage real and lasting change.

## **Membership Application Process**

- Prospective Members are introduced to the corresponding state caucus and invited to attend caucus meetings and events
- Fahe Member Services initiates call and/or site visit with prospective Member's executive director and key personnel
- Prospective Member submits a formal letter of request to join Fahe to Fahe Membership staff
- Fahe Membership staff extends invitation to submit application materials to prospective Members who demonstrate preliminary alignment with Fahe Membership criteria
- Prospective Member submits application and supporting documentation as detailed in the Fahe Membership Application (**Exhibit B**)
- Fahe Membership staff reviews application materials and provides a summary to the state caucus chair for presentation to the state caucus

- State caucus conducts a discussion without prospective Member present

- Fahe's board of directors acts upon the caucus recommendation at a regularly scheduled board meeting


